This Fourth of July, foster and adoptive families will have the opportunity to celebrate one of our most "laid back," fun-forall, family-oriented holidays. If your traditions include fireworks, barbecues, or relaxing days at the pool or beach, I have obtained safety tips from the American Red Cross that can help you prevent emergencies and enjoy a safer holiday:

Water safety at the pool and beach: The best thing anyone can do to stay safe in and around the water is to learn to swim. The Red Cross has swimming courses for people of any age and swimming ability. Contact your local Red Cross to inquire about swimming courses available in your community.

- Swim in a supervised, marked area with a lifeguard present, and swim with others. Never swim alone.
- Enter the water feet first. Enter the water headfirst only when the area is clearly marked for diving and has no obstructions.
- Adults should never leave a child unobserved around water. Practice "reach supervision" by staying within an arm's length of young children and weak swimmers while they are in and around the pool, lake, or ocean.
- Take frequent breaks (about once an hour) where everyone gets out of the water, drinks water, reapplies sunscreen (SPF 15 or higher) and rests.
- If you are caught in a rip current, swim

parallel to the shore until you are out of the current. Once you are free, turn and swim toward shore. If you can't swim to the shore, float or tread water until you are free of the rip current and then head toward shore.

- Watch out for the "dangerous too's": too tired, too cold, too far from safety, too much sun, too much strenuous activity.
- Post CPR instructions and directions to call 9-1-1 or your local emergency number in the pool area.
- Keep toys away from the pool when it is not in use. Toys can attract young children into the pool.
- If a child is missing, check the pool first. Go to the edge of the pool and scan the entire pool, bottom, and surface, as well as the surrounding pool area.

Firework safety:

There are nearly 9,000 emergency room-treated injuries associated with fireworks a year, according to the U.S. Consumer Product and Safety Commission. You can enjoy these Fourth of July staples safely by doing the following:

- Never give fireworks to small children, and always follow the instructions on the packaging.
- Keep a supply of water close-by as a precaution.
- Make sure the person lighting fireworks always wears eye protection.
 - Light only one firework at a time and never attempt to relight "a dud."
 - Store fireworks in a cool, dry place away from children and pets.

- Never throw or point a firework toward people, animals, vehicles, structures, or flammable materials.
- Stay at least 500 feet away from professional fireworks displays.
- Leave any area immediately where untrained amateurs are using fireworks.

Safe Grilling:

Nothing says summer quite like the smell of barbecue. Make sure safety is a key ingredient in your Fourth of July by reading the following tips for safer grilling:

- Use gas and charcoal barbecue grills outside only.
- Position grills far from siding, deck railings, overhanging branches and house eaves.
- Keep children and pets at least three feet away from the grill area.
- Never add charcoal starter fluid when coals have already been ignited.
- Always follow the manufacturer's instructions when using grills.
- Always supervise a barbecue grill when in use.

Dear Daisy

Dear Daisy:

I have been a foster parent to my child for 3 years now. We are in the process of adopting, but since she has become a teen she has been lying, sneaking out of the house, and disrespecting my rules. I don't think I can do this. What should I do? I love this child, but I don't think I can deal with these behaviors.

Dear Sad and Confused:

Serving as a foster parent/adoptive parent gives children a stable home while they are in your care. Fostering or fostering to adopt a child also comes with its share of difficulties. Recognizing these challenges helps you handle them when they arise. Management of the difficulties allows you to successfully foster children, meeting their needs during their stay with you.

Many children in foster care have special needs, including physical, emotional, or medical care. The child may be dealing with abuse, which causes psychological problems. Handling the extra needs of a foster care child adds difficulty to an already challenging situation. The foster parent must learn how to manage the special needs and deal with them on a daily basis.

Children in the foster care system face a number of emotional challenges. They may feel helpless, insecure, uncertain, guilty, or afraid to get emotionally attached to foster parents/adoptive parents. These emotions often result in difficult behaviors that parents find hard to handle. Children in foster care may be diagnosed with ADHD, anxiety disorders, autism or other psychiatric problems, which further complicate matters. Dealing with negative behaviors on a daily basis wears down many foster/adoptive parents, leaving them frustrated or exhausted.

The best tips are support, support, support! Attend monthly support meetings in your area to network with other foster parents. You can share experiences and know that you are not the only person who has dealt with some of these behaviors. Ensure that your child has as many services necessary to cope with issues of loss, anger management, any psychiatric problem, etc. Ask for respite—if you have a friend or family member that has passed background checks-they can watch the kids so you can leave for the day or if you want to leave overnight. Everyone deserves a break. Finally, make sure you keep your worker informed of what's going on with your child/your home. Your worker can help support your home and help prevent a possible disruption in your home.

I would like to nominate Shawn and Amber Encarnacion as the Care Providers of the Month for the Southeast Region. Shawn and Amber have taken their foster children into their home and have made them feel like they are family. Shawn and Amber put the girls first in many ways. They were living in a little apartment that didn't have room or any yard to play in, so they moved to a larger house which has a big yard for the girls to play in. After fostering their current placements, they plan on adopting these girls and giving them a home and a forever family.

Shawn and Amber make sure they participate in all the case plans and court hearings for the girls. They make sure they take the girls to all their appointments even when they are going to another town to mental health. Shawn and Amber have also driven to another town to facilitate sibling visitation with the girls' sister. The family understands the importance of connection and how maintaining this connection will make the transition from foster care to adoption occur smoothly.

Shawn and Amber didn't start out wanting to be foster parents. The family initially was interested in adoption only. They were interested in a particular child as they were going through the training process and that did not work out. The family was then asked to foster the two placements they have now, and it has transitioned to adoption. This family has done a great job adjusting from no children to two children and to becoming foster to adopt parents. They are always willing to partner with workers to make sure visits occur, as well as keep workers informed with what's going on in the girls' lives. The Encarnacion family is an excellent resource for children in Labette County and I am really fortunate to be assigned to their home.

If you are planning some time off this summer, here are a few ways to make your vacation earth-friendly and sustainable!

- "Stay-cations"— The idea is to stay home and visit museums and attractions in your own hometown
 or near your hometown. Not only does this save money (especially with gas at about \$4.00 a gallon!), but less driving means a healthier environment!
