Dear Foster Parent.

TFI Family Services, Inc. appreciates your dedication

and commitment to provide a loving home for children in foster care. We are committed to providing quality supports and service to your We want to ensure you have all the resources you need to support the children in your homes. This year we evaluated and changed our structure for reimbursement and have made an overall increase in our rates provided to Foster Parents. We project this new rate structure will increase payments to foster parents across our TFI network of homes by approximately a half of a million dollars a year! It has been a few years since foster parents have received a rate increase and we feel that it is needed and well deserved at this time. All new rates and changes will go into effect June 1st, 2013. Below are some details of the rate changes for the most common Levels of Care (LOC).

Spending quality time together in the great outdoors is what summer time is all about! Sharing these opportunities with the youth placed in your home can create lasting memories. If your travel plans include out of state travel, please make sure you connect with your Resource Family Worker with as much notice as possible. He or she will contact the Reintegration Team for your youth and get the approval necessary from the court in order for the child to leave the state with you whenever possible. There may be times when the travel is not approved, such as if it interferes with birth family visits, but for the most part it is something that can be approved with notice and planning.

# Green Tips

Crayons, markers and pens, Oh my! Arts and crafts is great for kids, but collateral damage of misplaced ink and stickers can be a challenge. Luckily, there are eco-friendly and family-safe cleaning agents to the rescue!

For crayon or maker on hard surfaces, scrub with baking soda and water.

For marker or pen ink on fabrics, blot with rubbing alcohol and repeat until it goes away. A word of caution – do not use vinegar for ink stains on fabric as it will likely set the stain.

For misplaced stickers, try covering with olive or coconut oil, letting it sit, sprinkling with baking soda then scrubbing with a dry cloth.

Our goal is to provide levels of reimbursement that match the needs of each child placed in your home. Part of this process includes removing the sometimes controversial "Step-Down" rate process within a level of care on June 1, 2013. However, we do know in some cases step-down rates can be beneficial and in those cases we will offer a choice. Each family with a current 'Step-Down' rate will be able to choose to keep that rate or can request a change to the new rate as indicated above. These new rates will provide a more consistent and overall higher level of reimbursement and will not result in anyone receiving a lower rate than they are receiving today for the level of care provided. The new rates will establish a foundation for your Resource Family Worker and TFI to advocate for a proper Level of care an appropriate rate for children placed in your home.

In summary, the key points about the new reimbursement structure:

- Rates to families have mostly increased or remained the same.
   No family will experience any decrease with the new rates.
- Rates will be based on two factors: 1. the youth's age, 2. the Level of Care (LOC) assigned.
- TFI and your worker will be the advocates to help ensure the proper LOC is in place by June 1st, 2013.

This is an exciting change and demonstrates our level of commitment to the service you provide to the children of Kansas. Most of you may have been informed of these changes by your worker ahead of this letter. If you have any questions regarding your rate of reimbursement, please contact your worker, they will be able to assist you. As you all know so well, your worker is your connection to all things important.

Love surmounts distance no matter how far away. As soon as DHHS informed the father living on the coast that his wife was jailed for felony child abuse, he boarded a plane and flew back to Nebraska. The children were quickly placed with him that same day. The next week, discussions with the family resulted in agreement that the father would ensure the safety of his children. A judge dismissed a petition to terminate parental rights. The family joined him, and the mother is receiving treatment. Quick action on the part of DHHS, the county attorney, the courts and the father kept the family together and placed them on the road to recovery.


## Recruitment Moment
