Dear New Care Provider,

Foster families are expected to treat foster children in their care as their own so wanting them to spend family vacations with you is only natural. Whether or not they can travel with you depends on many factors such as whether they have visits with their birth family scheduled over that time, etc. In addition, each county differs somewhat on what the court requires in order to approve out of state travel. Please let your Resource Family Worker know of your plans, giving as much notice as possible, and he/she will work with the Reintegration team, SRS, and the courts to get this approved.
